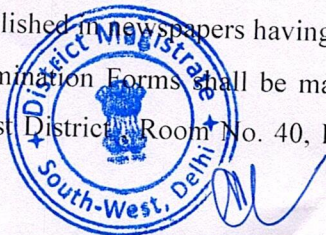

### General Instruction

- a. The election shall be conducted strictly in accordance with the provisions of the Multi-State Cooperative Societies Act 2002 (as amended), the Multi-State Cooperative Societies Rules, 2023, and the Registered Bye-Laws of the Society, to the extent they are not inconsistent with the Act and Rules.
- b. The Election Notification, Election Programme, Voter List, and all subsequent stages of the election process shall be prominently displayed on the Notice Board of the Society, its Branch Offices, and also uploaded on the official website of the Society for wide publicity.
- c. As required under Rule 191(3) of the MSCS Rules, 2023, the Election Notice shall also be published in newspapers having circulation in the area of operation of the Society.
- d. Nomination Forms shall be made available at Election At Office of the SDM(Matiala), South-West District, Room No. 40, District Magistrate(South-West)'s Office complex, Old Terminal



Tax Building, Kapashera, New Delhi-110037 from 19<sup>th</sup> to 21<sup>st</sup> May, 2026 (11:00AM to 3:00PM) Tuesday to Thursday, Nominations shall be filed in physical mode only at above address during nomination period as mentioned in election program.

- e. Members and prospective candidates are advised to carefully adhere to the provisions relating to eligibility, qualification, and disqualification for contesting elections, as laid down under Rules, 2023. Sections 29, 43, and 44 of the MSCS Act, 2002 and Rules 19J, 19K, and 19L of the MSCS
- f. Candidates shall also comply with the provisions relating to election expenditure under Rules 19U, 19V and 19W of the MSCS Rules, 2023. The account of election expenses must be maintained in the prescribed format and submitted to the Returning Officer within thirty (30) days of the declaration of results.
